

## Farhud: Never Forget

Edwin Black has organized 4 Farhud ceremonies within a 24-hour span. The first of which took place in Washington, D.C. at the U.S. House of Representatives.

The "Farhud," Arabic for "violent dispossession," was a pro-Nazi massacre against Baghdad Jewry that took place from June 1-2, 1941 - coinciding with the Jewish holiday of Shavuot. This terrible tragedy resulted in the death of hundreds of Sephardi Jews, marked the first step in ending 27 centuries of

peaceful Jewish existence in Iraq and Mesopotamia, and ultimately led to the expulsion of 850,000 Jews from the Middle

East into Israel. June 1-2, 2016 marks the Farhud's 75th anniversary.

## **LDB Urges UC Irvine Chancellor to Take Stronger Stance Against Disruptive Protest**

On May 24, LDB issued a letter to UC Irvine Chancellor Howard Gilman, addressing an aggressive protest that occurred on the campus the



prior week. In addition to violating several provisions of the UC Student Code of Conduct, the protestors violated California Law - specifically, California Penal Code 403, which makes it a misdemeanor to willfully disturb or break up any assembly or meeting that is not unlawful.
